A motion to accept the minutes of the October 01, 2014 meeting was made by John Ross and 2<sup>nd</sup> by James McFarland.

Ross and Amber Brown a Special Use Permit to host a Dog Club (Dock Diving) at 1091 County Route 10 for private practice and 5 public events.

Mr. Brown presented the application.

1. There is a dock and pool and the dog jumps in and the distance is measured.
2. Club members will use it for practice.
3. Dock and pool are movable and not permanent.
4. 20 spaces for parking.
5. Tent to keep dogs in the shade.
6. Access off County 10.
7. Not for profit.
8. Hudson River Air Dogs to be the name.
9. Register on line with Air Dogs and pay on site.
10. Presently 5 in club but will recruit more members.
11. Fun family sport. Few events to cover expenses.
12. No kennel will be set up.
13. Camp grounds are 15 minutes away.
14. Porta potty will be set up.
15. Events only Spring to Fall.
16. 3 to 5 events in all.
17. Insurance forms and liability for members and volunteers. Separate for public.
18. Presently an half an acre is used by farmers and will be reclaimed for the area of the pool.
19. 2.44 acres open 9 to 5.

20. Pool is portable and will remain up most of the time except when fair time comes.
21. Above ground 27,000 gallon pool will be locked with a gate.
22. Category will be a club.
23. Club does not own the land.

A motion to call it a club was made by Chip Keil and 2<sup>nd</sup> by Bernie Stickles.
